The Federal Government of Nigeria (FGN) has received financing from the African Development Bank towards the cost of the Special Agro-Industrial Processing Zones (SAPZ) Program Phase I in partnership with the State Governments and Private Investors in the five (5) participating States of Kaduna, Oyo, Cross River, Imo and Ogun and intends to apply part of the agreed amount for this loan to payments under the contract for the Development, Installation, Configuration and Commissioning Of Integrated Software Package For Monitoring, Evaluation (M&E) And Knowledge Management.
- 2. The consultancy services is for the development, installation, configuration and commissioning of integrated software package for monitoring, evaluation (M&E) and knowledge management. The services will include the development of a user-friendly, gender-responsive flexible but robust and centralized integrated M&E system across multiple projects to ensure cohesive tracking and evaluation of the SAPZ Programme; with potential for periodic expansion (upgrade), and capable of consolidating data on all value chain actors and MSMEs, and generating workplans and budgets, reports. Consultancy firms may constitute joint ventures to enhance their chances of qualification.
